

IDEA Grants Management Timeline

February 17, 2009 - Beginning of IDEA Recovery project period (the date the Act was signed) and first day funds may be obligated. The last day of the project period is September 30, 2011. Financial claims must be submitted at least quarterly.

June 30, 2009 – Last day to obligate 2008-2009 entitlement funds.

July 1, 2009 – Required assurances and budgets for 2009-2010 regular entitlement and Recovery grants due.

July 15, 2009 - Final 2008-2009 entitlement budget amendments are due.

August 21, 2009 – First quarterly Recovery financial claims are due for reporting period February 17 through July 31, 2009.

September 4, 2009 – PI-1505 Special Education Annual Reports for 2008-2009 are due.

September 30, 2009 – Last day to submit financial claim on 2008-2009 entitlement funds.

September 30, 2009 – Last day to submit requests to carry over more than 25% of 2008-2009 entitlement project year funds to 2009-2010.

October 16, 2009 – First quarterly 2009-2010 regular entitlement financial claims are due for the period July 1 through September 30, 2009.

November 1, 2009 – Last day to submit 2009-2010 Coordinated Early Intervening Services (CEIS) regular entitlement and Recovery budgets. Amendments are permitted after November 1, but the total CEIS funds budgeted may not be changed.

November 30, 2009 – Last day to enter web-based budget and claim application to report whether the LEA will file a Recovery financial claim for second quarter.

December 2, 2009 – Second quarterly Recovery financial claims are due for expenditures through November 30, 2009.

December 7, 2009 -- Second quarterly Recovery vendor/job impact surveys will be sent to LEAs that have submitted Recovery financial claims and received reimbursement. 12/29/2009

December 14, 2009 -- Second quarterly Recovery vendor/job impact surveys must be submitted to the DPI.

December 2009 – PI-1504 Special Education Budget Reports for 2009-2010 are due.

January 15, 2010 – Second quarterly regular entitlement financial claims are due for expenditures through December 31, 2009.

March 3, 2010 - Third quarterly Recovery financial claims are due for expenditures through February 26, 2010.

March 8, 2010– Third quarterly Recovery vendor/job impact surveys will be sent to LEAs that have submitted Recovery financial claims and received reimbursement.

March 15, 2010 -- Third quarterly Recovery vendor/job impact surveys must be submitted to the DPI.

April 16, 2010 – Third quarterly regular entitlement financial claims are due for expenditures through March 31, 2010.

June 7, 2010– Fourth quarterly Recovery financial claims are due for the expenditures through May 31, 2010.

June 15, 2010 – Fourth quarterly Recovery vendor/job impact surveys will be sent to LEAs that have submitted Recovery financial claims and received reimbursement.

June 23, 2010 – Fourth quarterly Recovery vendor/job impact surveys must be submitted to the DPI.

June 30, 2010 – Last day to obligate 2009-2010 regular entitlement funds.

July 16, 2010 - Final 2009-2010 regular entitlement budget amendments are due.

September 30, 2010 - Fourth quarterly (final) regular entitlement financial claims are due for expenditures through June 30, 2010.
